Comment: In response to the January 1, 2018 scheduled increase in minimum wage, the Executive Director seeks to keep substitute rates and payment methods compatible to expectations for exempt and non-exempt employees. Accordingly, the long-term certificated rate shall be increased to meet or exceed the weekly exempt salary formula for exempt classification. This rate shall be paid from the first day of the specified assignment, where the substitute is being hired with the intent to serve in a full-time teaching capacity for 30 or more days, continuously substituting for the same teacher. In doing so, the long-term substitute will have the same work schedule, duties and responsibilities as the regular teacher of record, for the duration of the long-term temporary exempt assignment.
- **d. Recommendation:** The Board is requested to approve the revised long-term substitute pay rate as presented.
